

A BILL TO BE ENTITLED  
AN ACT

1 To amend Title 10 of the Official Code of Georgia Annotated, relating to commerce and  
2 trade, so as to provide a short title; to provide a legislative declaration of authority; to define  
3 certain terms; to provide that products grown, produced, or manufactured and located in  
4 Georgia shall not be subject to federal law or regulations; to provide for exceptions; to  
5 provide for applicability; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 This Act shall be known and may be cited as the "State Authority and Intrastate Commerce  
9 Act."

10 **SECTION 2.**

11 Title 10 of the Official Code of Georgia Annotated, relating to commerce and trade, is  
12 amended by adding a new chapter to read as follows:

13 "CHAPTER 16

14 10-16-1.

15 The General Assembly declares that the authority for this chapter derives from the  
16 following:

17 (1) The Tenth Amendment to the United States Constitution, which guarantees to the  
18 states and their people all powers not granted to the federal government elsewhere in the  
19 Constitution and reserves to the state and people of Georgia certain powers as they were  
20 understood at the time that the citizens of Georgia ratified the Constitution. The guaranty  
21 of those powers is a matter of contract between the state and people of Georgia and the  
22 United States as of the time that the compact with the United States was agreed upon and  
23 adopted by the 13 original states of these United States;

24 (2) The Ninth Amendment to the United States Constitution, which guarantees to the  
 25 people rights not granted in the Constitution and reserves to the people of Georgia certain  
 26 rights as they were understood at the time the union of states was formed. The guaranty  
 27 of those rights is a matter of contract between the state and people of Georgia and the  
 28 United States as of the time that the compact with the United States was agreed upon and  
 29 adopted by the 13 original states of these United States; and  
 30 (3) The regulation of intrastate commerce vested in the states under the Ninth and Tenth  
 31 Amendments to the United States Constitution, particularly if not expressly preempted  
 32 by federal law.

33 10-16-2.

34 As used in this chapter, the term:

35 (1) 'Borders of Georgia' means the boundaries of Georgia as deduced from the  
 36 Constitution of Georgia; the Convention of Beaufort; the Articles of Cession and  
 37 Agreement with the United States of America entered into on April 24, 1802, which  
 38 defines the northern boundary of the state as lying along the 35th parallel; the Resolution  
 39 of the General Assembly dated December 8, 1826; and the adjudications and  
 40 compromises affecting Alabama, Florida, and South Carolina and are as described in  
 41 Code Section 50-2-1.  
 42 (2) 'Manufactured' means that a product has been created from basic materials for  
 43 functional usefulness.  
 44 (3) 'Produced' means grown, manufactured, assembled, mined, extracted, generated, or  
 45 created.

46 10-16-3.

47 A product that is produced commercially or privately in Georgia and that remains within  
 48 the borders of Georgia shall not be subject to federal law or federal regulation or under the  
 49 authority of Congress to regulate interstate commerce. Such items shall not be deemed to  
 50 have traveled in interstate commerce. This chapter shall apply to a product that is produced  
 51 in Georgia from basic materials or assembled from parts. The authority of Congress to  
 52 regulate interstate commerce in basic materials shall not include authority to regulate  
 53 products produced in Georgia from those materials or parts.

54 10-16-4.

55 A product manufactured or assembled in Georgia under this chapter shall have the words  
 56 'Made in Georgia' clearly stamped on an integral part. Products grown, mined, extracted,

57 or created in Georgia shall have the words 'Georgia Product' stamped on the container or  
58 packaging.

59 10-16-5.

60 The provisions of this chapter shall apply to products that are produced and retained in  
61 Georgia after July 1, 2010."

62 **SECTION 3.**

63 All laws and parts of laws in conflict with this Act are repealed.
